The suspect then attempted to flee the scene by vehicle, but the victim driver and passenger held on to the suspect's car door through the open window. The suspect drove off with the victim still hanging on, and then drove into a nearby parked car, hitting the victim, causing serious injuries to the victim and damage to the parked car. Deputies located and stopped the suspect vehicle a short time later. The suspect was arrested and booked into Main Jail.
