NOTICE TO REGNART ROAD RESIDENTS

Date: May 23, 2024

Subject: Regnart Rd. Improvements Phase I – Intermittent Lane Closure Notice Effective 05/28/24 – 06/12/24.

This is a follow-up to the notices distributed in early April 2024 to residents in the Regnart Road area to inform you that during the initial phases of the road repair work to mitigate roadway embankment distress and slope failures, current operations have revealed additional safety concerns that require a change in orientation / setup of drilling equipment to minimize further compromise to the roadway section and preserve worker and resident safety. As a result, **Brannon Corporation will be commencing regularly scheduled intermittent road closures of up to 25 minutes in duration, Monday through Friday, between 9am and 4pm starting on Tuesday, May 28th, 2024 and continuing until drilling operations are completed, which are anticipated to be completed on June 12th, 2024.** A table of road closure hours is as follows:
