### Cupertino Responds to PG&E Public Safety Power Shutoff

Due to high fire risk & weather conditions that include gusty winds, PG&E has announced a Public Safety Power Shutoff (PSPS). The Power Shutoff is expected to impact areas in Santa Clara County, including in Cupertino. The shutoff began on Wednesday, October 9 around 10:00 p.m. and will continue throughout the Red Flag Weather Conditions, which are forecast for a 24-hour duration. At this time, PG&E does not know when power will be restored, but the outage could last for up to seven days.

In response, the Emergency Operations Center has been partially activated to continue monitoring the situation. Cupertino Citizen Corps volunteers along with City staff have been canvassing on October 8 and October 9 in the neighborhoods anticipated to be impacted by the Power Shutoff with Informational Notices in English and Chinese (see attached).

Some City facilities will open Charging Stations for residents to charge small devices. Charging stations are available at the following locations an hours:

## Introducing Via-Cupertino!

Cupertino's Transportation Division is very excited to introduce Via-Cupertino, an on-demand shuttle service providing transportation anywhere in Cupertino and to Sunnyvale Caltrain! The system features Mercedes Metris vans, each equipped with a bike rack and wheelchair accessible.

To download the app search "Via" in the App Store or Google Play Store & look for the blue app icon!



### On-Demand Transit

On-demand transit means no schedules or routes to remember. Instead a van travels to you and takes you to your destination. After requesting a ride, the app shows the van's location and wait time (usually 15-17 minutes). Riders walk a short distance to meet the van to make trips direct and fast. Once on-board, as you make your way to your destination other riders board heading in the same direction. Mobility impaired riders can request door-to-door service.

### 2. Request a ride

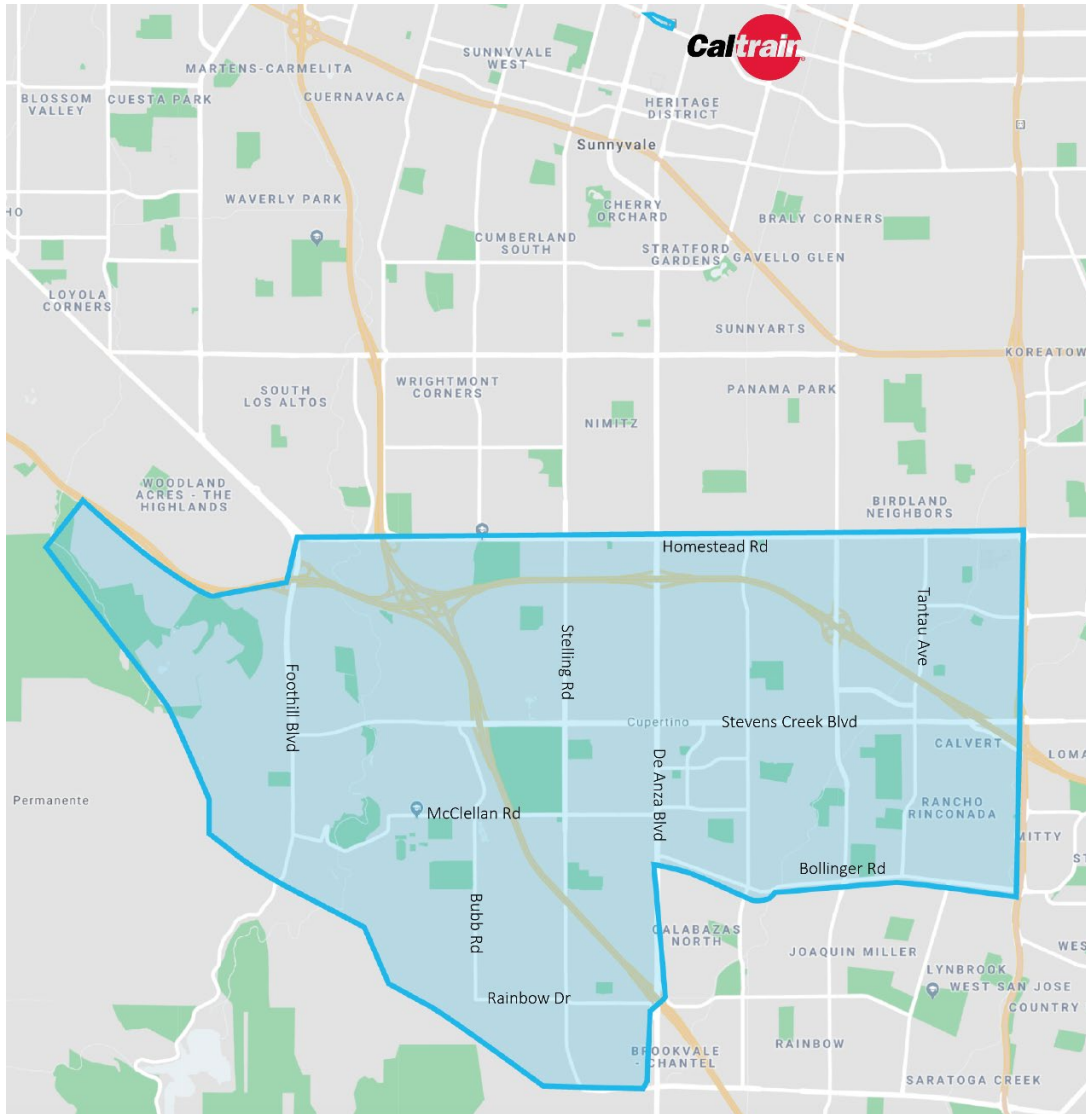
- Type your pickup address and destination in the app.

## Microsoft Office Workshops for City Staff

The IT Infrastructure Division is currently hosting a series of Microsoft Training Workshops for staff. The division has contracted Eric Ripley, with Shift Key Solutions, Inc., to provide training on Office 365, OneNote, Word, Outlook, and Excel.

To date the workshops have been well attended with over 100 staff attending at least one subject. Sessions are structured to be interactive consisting of exercise files to learn new skills and review new features included in Office 365.

## Coastal Cleanup Day 2019

On Saturday, September 21, the City of Cupertino welcomed 108 volunteers as part of Coastal Cleanup Day to clean a two-mile stretch of Calabazas Creek adjacent to Creekside Park (Stevens Creek Blvd to Bollinger Rd). Cupertino's site was honored to welcome Nai Hsueh, Valley Water Board Vice Chair and Director, District 5, who spoke to the group of volunteers as the event began, thanking them for their service and reminding everyone about the impact litter has on our local ecosystems. Four Valley Water Youth Commissioners also pitched in to collect litter and helped with sorting and weighing at the end. A total of 147 lbs of trash, 57 lbs of scrap metal, and 7 lbs of recyclable bottles and cans were pulled from the creek during the three hours of the event, including a heavily rusted car muffler, a bicycle, and remnants of a kiddie pool.

These events, held the third Saturdays of May and September, are a fun opportunity for community members of all ages to clean up our section of Calabazas Creek, and it

remains one of the best-attended cleanup locations in the County. Staff at Santa Clara Valley Water District collect results from all the cleanup sites in the County and reported that over 1,900 volunteers collected over 51,000 lbs of material from creeks and shorelines on Saturday morning. Cupertino's event was also mentioned several times in Valley Water's coverage of the event in [their newsletter from September 26, 2019](#), noting that, "At a cleanup site in Cupertino, one of the youngest volunteers was excited to help weigh the trash bags and determine how much litter was collected... 'He is very excited about saving the environment,' said Avin's dad, Divyesh Jain."

Thank you to the Cupertino volunteers and to all the people who participated at a cleanup event!



## Recap of Annual Garage Sale – September 28 & 29, 2019

On September 28 and 29, 168 households held yard sales at their homes as part of Cupertino's Annual Garage Sale. Community members from all over the Bay Area shop at this popular annual event. The 2019 Garage Sale was advertised in the Bay Area News Group Silicon Valley Community Newspapers, the San Jose Mercury classifieds, the World Journal, and on many yard sale directory websites. Over one thousand people used the online, interactive map created by our GIS division. This map, titled "Garage Sale Finder 2019," allowed users to search for sales by date and items for sale.

## Cupertino's 6<sup>th</sup> Annual Fall Bicycle Fest

On Saturday, September 28, 2019 Cupertino hosted the 6<sup>th</sup> annual Fall Bicycle Fest. There were many more participants, vendors, activities, and volunteers helping to run the event than ever before, and the community feedback we've received so far indicates this is Cupertino's biggest and best Bike Fest to date. New additions to the bike fest this year were bike safety clinics, cargo bikes on display, bike safety gear for sale, and contests to see who had the most magnificent bike in three different categories. The Bike Fest also hosted activities held in previous years, including helmet fitting, an educational bike rodeo and obstacle course for kids by leading bike educator Safe Moves, two bike rides led by the Bicycle Pedestrian Commission, blender bike smoothies, bike decorating and face painting. 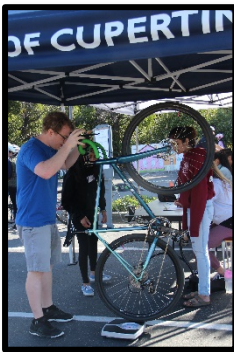

## Notice of Public Safety Power Shutoff – October 9, 2019

Due to high fire risk & weather conditions that include gusty winds, PG&E has announced a Public Safety Power Shutoff (PSPS). The Power Shutoff is expected to impact areas in Santa Clara County, including in Cupertino, as early as **12:00 a.m. October 9**. You are receiving this courtesy notice because your residence may be impacted. Residents are advised to prepare for having no power for **up to seven days**.

To prepare for the PSPS event, residents are encouraged to:

- **Update their contact information** at [pge.com/mywildfirealerts](http://pge.com/mywildfirealerts) or by calling 1-866-743-6589 during normal business hours. PG&E will use this information to alert customers through automated calls, texts, & emails, when possible, prior to, & during, a Public Safety Power Shutoff.
- **Plan for medical needs** like medications that require refrigeration or devices that need power.
- **Identify backup charging methods for phones** & keep hard copies of emergency numbers. Below is information on Charging Centers that will be open for residents.
- **Build or restock your emergency kit** with flashlights, fresh batteries, first aid supplies, & cash.
- Keep in mind family members who are **elderly, younger children, & pets**.

## **PG&E Public Safety Power Shutoff UPDATE – October 10, 2019**

Due to high fire risk & weather conditions that include gusty winds, PG&E has announced a Public Safety Power Shutoff (PSPS). PG&E began shutting down power in Santa Clara County starting around 11:00 p.m. last night. High winds are expected to continue into the afternoon and then taper off. Once the weather event passes, PG&E will assess their lines to ensure they are safe to power back on. At this time, PG&E does not know when power will be restored, but the outage could last for up to seven days in total. Tune into Radio Cupertino at 1670 AM for updates.

### **During a power shutoff, PG&E encourages residents to take these steps:**

- Unplug or turn off appliances, lights, equipment, and electronics to avoid damage caused by surges when the power is restored.
- Leave a single lamp on to alert you when the power returns. Then turn your appliances on one at a time.
- Typically, your refrigerator will keep food cold for about 4 hours and a full freezer will keep its temperature for about 48 hours--if the freezer and refrigerator doors are kept closed. Consider using coolers with ice to keep food cold and safe.
- Be sure to use generators, camp stoves, or charcoal grills outdoors only. Do not use a gas stove for heat.
- Check on your neighbors.

### **Resources that Are Available to You During the Power Shutoff:**

- For dangerous situations that threaten life or safety, call 9-1-1. If you are unable to call 9-1-1, report to the Monta Vista ARK at the Monta Vista Fire Station, 22620 Stevens Creek Blvd.
- To access social services such as food, shelter, counseling (and more), call 2-1-1.

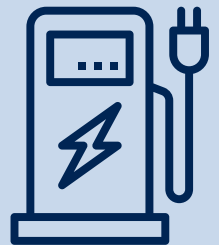
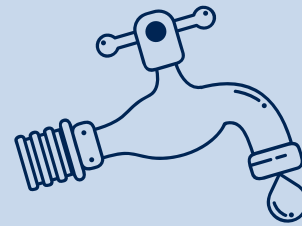
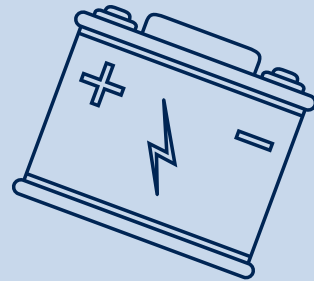
