News and Updates Regarding COVID-19

City Communications Regarding COVID-19 (Coronavirus)

The City of Cupertino continues to monitor the effects of the coronavirus (COVID-19) as the safety of our residents remains our highest priority. All City facilities remain closed until further notice. While City Hall is closed to the public, the City continues to provide essential services online at cupertino.org and by phone at (408) 777-3200. These essential services include responding to 311 requests and maintaining the City's infrastructure, among others. Cupertino Walgreens Offering Free COVID-19 Testing

The Cupertino Walgreens at 20011 Bollinger Road is offering free, drive-thru COVID-19 testing. Testing is available seven days a week from 9 a.m. to 5 p.m. No appointment is necessary, but those who make an appointment will be served first. Individuals must be 18 and older and do not need to have health insurance.

The nasal swab test is self-administered and does not test for antibodies. When you arrive at Walgreens, follow the signs and bring a valid ID and insurance card if you have insurance. Results will be available in three to four days.

City Reports on Unemployment Insurance Claims

The California Employment Development Department (EDD) provides a variety of support services to people who have lost their jobs, had their hours reduced, or had their businesses affected due to the impacts of COVID-19 in California. Private sector employers typically finance the Unemployment Insurance (UI) Program by making tax contributions, or in the case of many municipal agencies including the City of Cupertino, through a direct pay program.

California residents may be eligible for UI benefits for a variety of reasons including:

- Their employment status has been affected by COVID-19 and they are fully or partially unemployed as a result.
- They are fully or partially unemployed. This includes layoffs, furloughs, reduced wages, or reduced hours. They can still receive unemployment benefits while working, depending on their pay.
- Their child's school is closed, and they need to miss work to care for them.

The City of Cupertino saw a dramatic increase in UI claims received between March 19 and July 23 when Governor Gavin Newsom's Executive Order began, requiring all non-essential businesses to close and non-essential governmental employees remain at their homes. During this same time, the City received nearly 100 UI claims which cost the City \$106,890 for the second quarter 2020 payment to the EDD. In comparison, the first quarter 2020 payment to the EDD was \$6,848—a 1461% increase. According to the Bureau of Labor Statistics (BLS), the June 2020 unemployment rate in California was 14.9%. By comparison, the June 2019 unemployment rate was 4.0%, which is a year-over-year change of 10.9%.

Under Section 2103 of the Coronavirus Aid, Relief, and Economic Security (CARES) Act of 2020, the City is eligible to receive 50% relief of the amount of UI benefit compensation paid for weeks of unemployment beginning on or after March 13 and ending on or before December 31. This reimbursement from the EDD does not count towards the CARES Act City allocation of \$735,259.

New Check-In Application for Entry into City Facilities

The City's Office of Emergency Services and Innovation Technology Department worked together to build a custom facility check-in application. The app is an online form that requires users to answer a health questionnaire. It also keeps a digital log of visitors to City buildings.

The app prepopulates some information, which helps expedite the process for staff. Employees are required to check in at each building, but temperatures only need to be taken once per day. Employees can check in by using a City tablet available at each facility or their own device. Once City buildings are open to the public, visitors will be required to fill out the form and have their temperature taken by a staff member. This electronic process allows the City to reduce its dependence on paper forms and eliminates the potential challenge of deciphering hand-written answers. The form can be accessed via phone or smart device by scanning a QR code or through this link [here](#).

The app also acts as a digital dashboard. This allows staff to monitor who and how many people are visiting City facilities. The dashboard would help the City determine who an individual might have been in contact with if they end up testing positive for COVID-19.

Increase in Cupertino 311 Requests

The Cupertino 311 portal is the most efficient way to report maintenance issues. It's simple and easy—you can go to cupertino.org/cupertino311 or download the app on Google Play or the Apple store.

Since Santa Clara County's Shelter-in-Place Order was announced on March 16, the Public Works Service Center has seen a 320% increase in the use of Cupertino 311 by residents.

For the time period of March 16 to July 31, City 311 requests totaled 585. Of those requests, 375 were for Public Works maintenance:

- 255 for trees
- 61 for sidewalks
- 22 for roadways (including streetlights)
- 19 for parks
- Seven for graffiti
- Six for street sweeping
- Five miscellaneous

Of these 311 requests, 100% were responded to within two days and 94% have been resolved.

In comparison, during the time period of November 1, 2019 to March 15, 2020, requests totaled 464. Of this total, 89 requests were for Public Works maintenance.

The Public Works Service Center has been staffed since the Shelter-in-Place Order was announced. Initially, operations were limited to a handful of personnel who responded to 311 requests. By April and May, staffing increased to nearly two-thirds and on May 4, necessary safety protocols were in place and full staffing resumed.

Care Cards for Local Seniors

The Cupertino Senior Center and Harker School's Key Club partnered to write letters to local seniors with limited social contact due to the pandemic. To date, this partnership has mailed more than 150 letters with uplifting messages and short stories.

"It felt personal to receive a hand-made card with a handwritten note, not typed," one resident shared. "In their message, they were imagining how I must be feeling...that shows compassion."

Proper Management of Unwanted Household Items

The City of Cupertino's Environmental Programs partnered with the Office of Communications to mail a letter to every Cupertino household as a reminder of how to properly discard of unwanted items.

The mailer includes disposal options with contact information for scheduling on-call collections with Recology, how to schedule a drop-off appointment with Santa Clara County's Household Hazardous Waste Program, and several web-based resources for selling and donating. The mailer outlines how to properly place items out for pickup without causing safety concerns, with emphasis on not blocking the sidewalk and maintaining a safe and accessible right of way. County Proposal Regarding Lehigh's Reclamation Plan Amendment

On August 5, the Santa Clara County Department of Planning and Development proposed to the County Board of Supervisors (BOS) that an evidentiary hearing be conducted concurrent with BOS consideration of Lehigh's 2019 Reclamation Plan Amendment application and potential modification of the Scenic Easement. The purpose of the evidentiary hearing is for the BOS to consider surface mining activities proposed by Lehigh and to determine if these activities are consistent with the vested rights determination made by the BOS in 2011. Activities that exceed Lehigh's vested rights require a use permit.

The 2011 vested rights determination made by the BOS determined that Lehigh holds the vested right to conduct quarry surface mining operations on vested parcels. However, as the County staff memo explains, because the 2011 vested rights determination focused on the geographical extent of Lehigh's vested right, it did not delineate the substantive scope of that right—precisely which surface mining and related activities are consistent with the vested right. The specific activities that County staff is proposing the BOS to consider in the hearing is the proposed off-site sale of unprocessed greenstone and physical export of the commodity, and the proposed increase in production volume associated with the opening of the new Rock Plant Quarry area.

As a reminder, Lehigh proposed in their application the following new surface mining and related activities:

- Expanded excavation and layback of the north highwall of the North Quarry Pit
- Expanded surface mining in the new 30-acre Rock Plant Reserve area, south of the North Quarry Pit
- Reactivation and use of the Quarry's existing rock crusher
- Hauling of unprocessed aggregate to the adjacent Stevens Creek Quarry via an internal haul road

The expanded surface mining activities would increase total mining production by approximately 600,000 tons per year. Also proposed are activities to reclaim expanded surface mining operations, including importation of 20 million cubic yards of clean fill to backfill the North Quarry Pit for reclamation and retention of overburden and mine waste stored on-site at the West Materials Storage area.

Staff from the City’s Public Works Department and City Attorney’s Office have previously evaluated the Lehigh application and have provided input to County staff. This August 5 memo is also being reviewed and staff will similarly provide additional input.

Regarding future timeline, the County is finalizing the scope of work with their Environmental Impact Report (EIR) consultant to complete the EIR for the Lehigh application. When this is complete, the County will then issue a Notice of Preparation that will begin the public input process for the EIR. The EIR process will take several months and upon completion will go to the County Planning Commission before going to the County BOS to be considered along with Lehigh’s application and any evidentiary hearing. It is estimated to take a minimum of eight months to a year for this process to be complete.

<hack> Cupertino Announces Winners

The Cupertino Teen Commission and Parks and Recreation staff took the award-winning <hack> Cupertino 2020 event virtual this year. This year’s theme was Civics. Teen coders were challenged to create a solution to a civics-related problem in their local communities.

Participants had one week to address the prompt and work with their group to impress judges Gopal Kumarappan from the Parks and Recreation Commission, Naidu Bollineni and Rajarm Soundarajan from the Technology, Information, and Communication Commission, and Rajeswari Mahalingam from the Fine Arts Commission.

The competition was fierce with over 120 participants and 43 submissions. After six days of judging, the champions of <hack> Cupertino 2020 were revealed at the closing ceremony and our winners include the following students with links to their projects and video submissions:

Re: Bulky Items and Waste Disposal Options

Dear Resident,

I hope this letter finds you healthy and your loved ones safe as you shelter at home.

Many residents are taking this time to do a bit of spring cleaning and clear out unwanted items. Unfortunately, some of these items are being left on sidewalks, blocking accessibility and creating safety issues. To keep everyone safe while avoiding code violations, I would like to remind residents about available services and how to place items for pickup.

- **Bulky Items (like furniture or appliances) and Extra Debris:** Residents can request two, free on-call pickups a year. Extra pickups can be scheduled for a fee. Contact Recology at recologysouthbay@recology.com or (408) 725-4020.
- **Donating:** Many traditional thrift stores (such as Goodwill, Savers, and Salvation Army) are closed or have limited hours. But there are online options for posting items to sell or donate (see reverse side for ideas).
- **Placement:** Place items out for pickup **no more than 24 hours** before the scheduled collection. If leaving items in your driveway for Recology to pick up, place them at the bottom of the driveway so that Recology can easily reach them. Items cannot be left on the sidewalk or in the street.

The back of this letter lists resources to help you properly dispose of unwanted items. Together we can maintain a safe, attractive, accessible city, and Environmental Programs staff is available to help answer any questions you have. Contact us at environmental@cupertino.org or (408) 777-3236.
