City Communications Regarding COVID-19 (Coronavirus)

The City of Cupertino continues to monitor the effects of the coronavirus (COVID-19) as the safety of our residents remains our highest priority. All City facilities remain closed until further notice. While City Hall is closed to the public, the City continues to provide essential services online at cupertino.org and by phone at (408) 777-3200. These essential services include responding to 311 requests and maintaining the City's infrastructure, among others. Community Letter Regarding COVID-19 Fiscal Impacts

The City of Cupertino—along with municipalities across the country—has been negatively impacted by the global COVID-19 pandemic and ensuing economic crisis. Tennis Courts and Golf Course Reopened

The tennis courts at the [Sports Center](#), Memorial Park, Monta Vista Community Center, Varian Park, and the [Blackberry Golf Course](#) are open at this time. Players are only allowed to use the tennis courts with members of their households. Proper social distancing must be followed. The Sports Center tennis courts will only be available to Sports Center members. The Sports Center facility will remain closed. Public Works Operations Back to Full Staffing

Due to the essential services performed by the Public Works Department, the Service Center (located at 10555 Mary Avenue) returned to full staffing on Monday, May 4. Service Center staff—which includes approximately 60 employees—maintains grounds, street trees and medians, street pavement and markings, storm drains, building facilities, and the City's vehicle fleet. The Service Center will remain closed to the public.

City employees will take precautions that include strict adherence to physical distancing requirements, wearing of personal protective equipment including face coverings, daily health checks, and regular sanitation of work areas.

To request service from the Service Center, call (408) 777-3269 between 6:00 a.m. and 3:30 p.m. Mondays–Thursdays, and 6:00 a.m. to 2:30 p.m. on Fridays. Service requests can also be made 24/7 by visiting cupertino.org/311.

Recology Resumes Normal Service

Recology has resumed normal services including on-call collection and bulk item pick-ups. All on-call and extra pick-up materials must be securely bagged or boxed with nothing loose except for bulk items. If residents have extra garbage, they can contact Recology for collections options at (408) 588-7200.

Staff Monitoring Utility Impacts During Shelter-in-Place

Since City facilities have been effectively closed to the public and most staff since early March, the City has been monitoring energy and water consumption changes to municipal facilities. The data shows that Cupertino's municipal energy expenses will be reduced between 15% to 25% during the months of March and April. Recognizing that home utility bills will likely rise with more time spent in the household, the Sustainability Division has provided resources that may be useful for the broader community:

Cupertino Summer Event Cancellations

The City of Cupertino has canceled in-person summer events that attract crowds of 100 people or more due to the ongoing COVID-19 pandemic and extended Shelter-in-Place Order. This includes Shakespeare in the Park, Summer Concerts, Summer Movies, Cupertino Campout, and the Corridor Stroll.

The City understands that this announcement will disappoint many residents who look forward to attending these events every year. However, this decision is in the best interest of our community. The City hopes you and your family will join us in 2021!

2020 Independence Day Celebration Canceled

The City of Cupertino has canceled its annual Independence Day Celebration due to the ongoing COVID-19 pandemic and extended Stay-at-Home and Shelter-in-Place Orders.

"This was a difficult but necessary decision for the health and safety of our community," Mayor Steven Scharf said. "Our Independence Day Celebration, including the nighttime fireworks show, is one of the most beloved community events the City hosts each year. I look forward to the day when we can bring it back."

Past celebrations—which attract thousands of guests and spectators—have included a pancake breakfast, children’s carnival, flag raising, children’s parade, concert, swimming, and the ever-popular fireworks show.

Update Regarding Homeless Encampments

The City of Cupertino continues to receive messages from residents regarding homeless encampments within Cupertino. Homeless encampments cannot be broken up unless individual housing units are identified, according to Centers for Disease Control (CDC) guidelines. The CDC states: “Clearing encampments can cause people to disperse throughout the community and break connections with service providers. This increases the potential for infectious disease spread.” Due to this guidance, the County of Santa Clara has exempted the homeless in its Shelter-in-Place Order.

City’s Action Plan for Housing and Community Development Available

The City’s draft of the [2020-2025 CDBG Consolidated Plan and FY 2020-21 Annual Action Plan](#) document is available on the City’s [CDBG webpage](#) from May 5 to June 5 for public review and comment. The Consolidated Plan outlines the City’s housing and community development needs and provides an action plan on how the City intends to use its federal funds to address those needs. The Consolidated Plan and Annual Action Plan are designed to correspond with adopted goals from the City’s General Plan Housing Element. Every five years, the U.S. Department of Housing and Urban Development (HUD) requires that the entire Consolidated Plan be updated. The draft document is scheduled to go before the Housing Commission on May 14 and City Council on June 2.

Cupertino Junipero Serra Trail Project Recommended for Funding

On April 20, the City’s Public Works Department submitted the Junipero Serra Trail project for the 2016 Measure B Bicycle and Pedestrian Capital Projects Competitive Grant program. Based on VTA scoring committee results from the review of all local agency project applications received, VTA staff is recommending that two Cupertino trail projects—the Junipero Serra Trail East and Junipero Serra Trail Central segments—be recommended to be on the 10-year priority funding list, for a total funding allocation of \$6.12 million.

The Junipero Serra Trail comprises a generally east-west trail segment that will deliver a significant portion of “The Loop,” a bicycle route that comprises several high-priority projects, encircles Cupertino, and will link a number of popular destinations. The East and Central segments will parallel the Junipero Serra channel south of Interstate 280 between De Anza Boulevard and Calabazas Creek, and along Calabazas Creek from Interstate 280 to Vallco Parkway. This project was ranked a Tier 1 high priority project in the Cupertino Bicycle Transportation Plan and Pedestrian Transportation Plan.

VTA advisory committees will act on the item this week, followed by VTA standing committees the week of May 18. The VTA Board of Directors will act at its June 4 meeting.

Interactive Cupertino 311 Public Dashboard Now Live

The City's Geographic Information System (GIS) Division has published an interactive 311 dashboard that provides residents an overview of public service requests received by the City's residents and visitors (private requests have been filtered out due to sensitive information). These requests are submitted via Cupertino 311's mobile application, email, or phone.

The easy-to-navigate dashboard presents service request data in interactive tabular, chart, and GIS map formats. Each service request is listed and provides the following information:

- Type of request (Street, Trash, Property Use, etc.)
- Date created/closed
- Location
- Status of request (open/closed)
- Average timeframe to close requests by type

#CupertinoCares Initiative

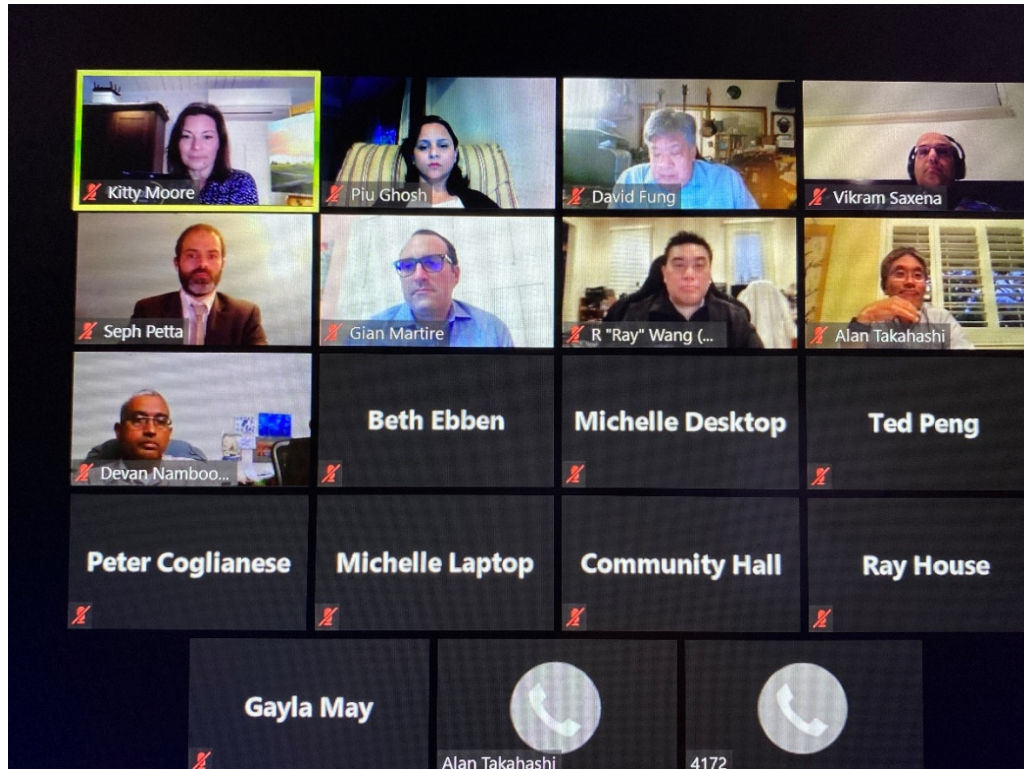

Commission and Committee Meetings Continue

While the COVID-19 Shelter-in-Place Order may have stopped many in their tracks, it has not stopped the Planning Commission, Design Review Committee (DRC), and the Planning Division from conducting normal business. In a historic first, on April 14, the Planning Commission met at a virtual meeting online to consider a Conditional Use Permit for a pre-school and after-school care business. Public input was accepted and after thoughtful discussion and deliberation, and two added conditions of approval drafted in real-time by staff, the Planning Commission

approved the project unanimously. Coincidentally, the DRC also had its first virtual meeting that same week, meeting on April 16 to review a Sign Exception application for additional gas station signs. After a thoughtful discussion, the DRC approved the project as recommended. Staff support for these meetings was provided by the Planning Division of the Community Development Department.



Public meetings staffed by the Planning and Housing Divisions will continue to be scheduled as required through the time that the Shelter-in-Place Order is in effect.

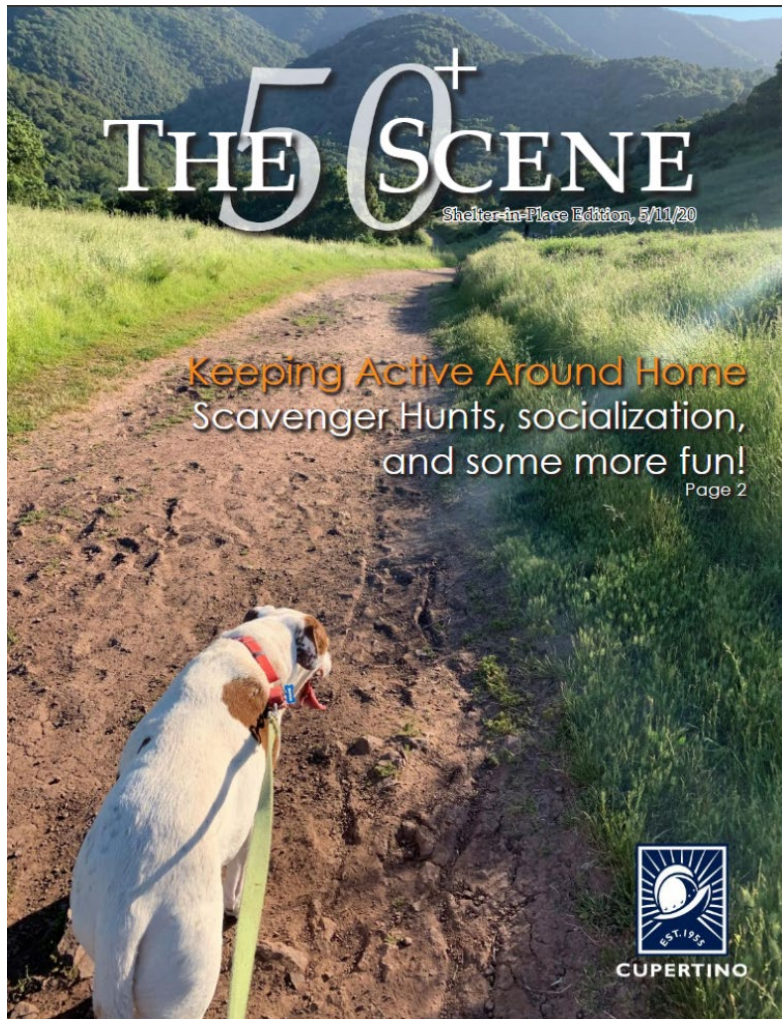
