General City News and Updates

Santa Clara County Now in State's Orange Tier

The County of Santa Clara moved into the State of California's Orange Tier (Tier 3). The Public Health Officer's new Revised Risk Reduction Order (issued October 5) went into effect at 12:01 a.m. on October 14. Changes include allowing indoor dining and indoor gatherings, with limitations, and capacity increases for museums, zoos, and retail operations.

The fact that these additional activities and capacity are now allowed should not be construed as implying such activities are safe. COVID-19 continues to pose a serious risk throughout our County. Everyone must remain cautious, maintain social distance, wear a face covering, and move activities outdoors when possible.

While the County is moving into a new tier, there are differences between what the State allows and what the County permits. Unless otherwise indicated in the local Health Order, all County businesses and activities can resume to the extent allowed under the Orange Tier. The following business categories are now allowed to be open indoors with the following capacity limitations:

- Outdoor gatherings of up to 200 people and indoor gatherings of up to 25% capacity or 100 people, whichever is fewer. This includes movie theaters, churches, and cultural ceremonies. The State generally prohibits other gatherings.
- Indoor dining up to 25% capacity or 100 people, whichever is fewer
- Indoor museums and zoos up to 50% capacity
- College sports activities without fans following County and State requirements
- No capacity limitation for malls and other retail businesses

2020 Election Season Upon Us

You can vote today in the 2020 General Election by casting your vote-by-mail ballot. Ballots for the 2020 Election have been mailed to all registered voters in Santa Clara County. Fill out your ballot, then mail it for free or take it to a ballot drop box. The ballot drop boxes in Cupertino are located at:

- Cupertino City Hall, 10300 Torre Avenue
- Quinlan Community Center, 10185 North Stelling Road
- De Anza College Student Center, 21250 Stevens Creek Boulevard

In-person voting opportunities will also be available throughout the County at various Vote Centers starting October 31. On Election Day, November 3, all Vote Centers will be open from 7 a.m. to 8 p.m. for voting.

Pavement Work Begins on McClellan Road

The City of Cupertino's contractor, Pavement Coatings Co., has started work to place a rubberized asphalt cape seal on McClellan Road between Bubb Road and portions of Stelling Road. The application of an asphalt chip seal took place on Monday, October 19 and Tuesday, October 20. That work will be followed by the application of a slurry seal on Monday, October 26 and Tuesday, October 27. Work will be done between 8 a.m. and 5 p.m.

McClellan Road will be reduced to one lane during these periods. A flagger will conduct traffic control to allow travel in both directions. Motorists should expect delays while work is in progress and are advised to use alternate routes when possible.

Access to and from side streets and driveways will be restricted for intermittent periods during this work. Residents with access off McClellan Road are requested to park on side streets if they will need to access their vehicles during these periods.

City Picnic Site Reservations Begin

The City of Cupertino started taking picnic site reservations on Wednesday, October 21. Reservations can be made online at reg4rec.org or by calling the City's Recreation Office at (408) 777-3120.

Picnic site users should follow social distancing recommendations, wear a face covering, practice good hygiene, and follow the guidelines put forth by the County of Santa Clara and the State of California Public Health Departments.

Picnic Rental Guidelines:

- Please stay home if you are feeling sick or have been exposed to someone with COVID-19.
- Anyone who develops COVID-19 within 48 hours after attending a gathering should notify the other attendees as soon as possible regarding the potential exposure.
- Gatherings should be two hours or less. The longer the duration, the risk of transmission increases.
- People at higher risk of severe illness or death from COVID-19 (such as older adults and people with chronic medical conditions) are strongly urged not to attend any gatherings.
- Gatherings that include more than three households are prohibited. This includes everyone present, including hosts and guests.
- The host should collect the names of all attendees and contact information in case contact tracing is needed later.
- Masks must be worn except when sitting to eat or drink.
- For any gatherings permitted under this guidance, the space must be large enough so that everyone at a gathering can always maintain at least a six-foot physical distance from others (not including their own household).

- Everyone at a gathering should frequently wash their hands with soap and water or use hand sanitizer if soap and water are not available. A place to wash hands or hand sanitizer must be available for participants to use.
- Shared items should not be used during a gathering. As much as possible, any food or beverages at outdoor gatherings must be in single-serve disposable containers. Self-serve items from communal containers should not be used.
- Visitors should bring plastic tablecloths that can be disposed of or taken back home for washing.
- Gatherings should not exceed the current maximum number of people allowed in the State and County COVID-19 guidelines.

Celebrate Halloween Safely to Prevent the Spread of COVID-19

A reminder to the community that many commonly celebrated Halloween and Día de Los Muertos activities carry a high risk for spreading COVID-19. Focusing on decorations, limiting activities to the people you live with, and virtual costume parties or contests will help keep our communities safe this season, especially our children.

Parties and trick-or-treating are considered high-risk activities because increasing contact with people outside of your household introduces more opportunities for the virus to pass from one person to another. Bay Area contact tracing has shown that gathering and mixing are key contributors to infection.

Stay home if you feel sick or have come into close contact with someone who has COVID-19. Wear a face covering whenever you leave home, keep your distance from others (even relatives) who don't live in your household, and remember that being outside is safer than being inside, especially in combination with face coverings and keeping your distance. Consider using a themed cloth mask, as a costume mask is not a substitute. Avoid wearing a costume mask over a protective cloth mask because it can be dangerous if the costume mask makes it hard to breathe.

Make sure any activities you have planned are in compliance with local and State [Health Orders](#).

To further protect yourself and your loved ones, be sure to monitor yourself during the 14 days after these holidays. Pay particular attention from three to seven days after, when you are most likely to develop symptoms. If you don't feel well or learn someone you had close contact with tested positive, get tested immediately, and stay home until your appointment and while you wait for your results. Business Updates

Orange Tier Allows Additional Businesses and Activities to Resume

Under the Revised Risk Reduction Order, many additional activities and business operations can resume, including indoor dining and indoor gatherings with conditions.

Indoor dining is allowed, subject to various safety requirements. Under the revised Order, restaurants may open for indoor services up to 25% of the indoor capacity limit or 100 people, whichever is fewer. Bars, breweries, brewpubs, pubs, and distilleries are not allowed to operate indoors, unless they provide sit-down meal service in accordance with the rules for indoor dining. Otherwise, these businesses may now provide outdoor sit-down service subject to restrictions. The rules for dining are in the Health Officer's revised [Mandatory Directive for Dining, Bars, Wineries, and Smoking Lounges](#).

The revised Order strongly discourages gatherings, especially indoors, because convening with other households for long periods poses a particularly high risk of COVID-19 transmission. However, both outdoor gatherings of up to 200 people and indoor gatherings up to 25% capacity of 100 people, whichever is fewer, are allowed. The rules for gatherings (including theaters) are in the revised [Mandatory Directive for Gatherings](#).

The Orange Tier allows some additional activities that were not allowed in the Red Tier:

- Indoor pools may now open
- Some family entertainment centers may now operate indoors, but only those facilities used for naturally distanced activities (such as bowling alleys) with a limited capacity

All businesses and organizations are required to submit revised Social Distancing Protocols by October 28, within 14 days of the Revised Order taking effect. More information and instructions on how to submit a new Social Distancing Protocol are available [here](#).

Cupertino's Annual Fall Bike Fest 2020

Cupertino's seventh annual Fall Bike Fest was held online in conjunction with Bay Area Bike to Wherever Days during the entire month of September. The Cupertino Safe Routes to School team (SR2S) posted six ride routes for riders of all levels to try at their leisure. They also posted one or two new challenges each week to encourage riders to Bike the Parks, Bike to School, Bike to Shop, log their rides on a platform called Love to Ride, post their stories there, and compete for who could carry the most by bike. Riders who submitted a photo of these challenges or signed up on Love to Ride earned various prizes. The prizes varied from "I Bike Cupertino" t-shirts to travel mugs, mini bike lights, gift certificates to local shops, and SR2S packages which included items for children. Roughly 149 participants submitted 121 photos for the various challenges and earned 192 prizes, which are being distributed this week and next.



The event was advertised through the City's social media channels and e-notification lists to encourage Cupertino residents to get on their bikes and have fun, get exercise, and try biking as a mode of transportation. Staff received very positive feedback from participants.

New Virtual Program for Teens to Connect

On Tuesday, October 13, the City's Parks and Recreation Department launched Cupertino Connect, a new virtual program created for teens to socialize and connect while schools remain closed. Members of the City's Youth Activity Board (YAB) will work with City staff to create weekly events in which teens can participate. Cupertino Connect will meet every Tuesday and Thursday from 4 p.m. to 5 p.m. and engage with YAB members throughout the events. Cupertino Connect is free and participants may register at reg4rec.org.

Info-Teeno: Financial Preparedness Webinars

The City of Cupertino's Parks and Recreation Department and Youth Activity Board (YAB), in partnership with KeyPoint Credit Union, launched the first of a three-part series to give youth and teens the knowledge they need to make wise financial decisions in college and beyond. On Sunday, October 18, the first webinar, "Basics of Money Management," reviewed different types of financial institutions and the products, services, and tools they provide to help money management. Over 50 teens and parents registered for the webinar and participated in a Q&A session with financial professionals. Survey respondents gave the first webinar of this series a four-point-eight out of five stars.

The second webinar, "Understanding Credit," will be held on Sunday, November 15 at 1 p.m. This webinar will cover credit scores, the importance of establishing credit, building credit, and protecting one's credit. The third webinar, "Making Good Money Decisions," will be held on Sunday, January 24 at 1 p.m. The third session will go into more detail on managing money, setting goals, and building a strong foundation for future financial health.

Pizza and Politics 2020

The Youth and Teen Commissions of Cupertino, Saratoga, and Campbell reunited on Friday, October 9 to host the fifth Pizza and Politics, a biannual political forum coordinated by youth for youth. Pizza and Politics encourages youth and teen civic engagement, makes politics more accessible to young people, and provides a platform to interact with politicians.



This year’s event moved to a virtual format and was streamed live on the City’s YouTube channel and Facebook page. This year’s event included three segments: a Mayor’s Roundtable, State of the California State Assembly with a Q&A for District 28, and debate with a Q&A with Senate District 15 candidates. Special guests included Mayor Steven Scharf from Cupertino, Mayor Susan Landry from Campbell, Mayor Howard Miller from Saratoga, District 28 incumbent Assemblymember Evan Low, Santa Clara County Supervisor Dave Cortese, and Senate candidate for District 15 Ann Ravel.

For the first time, Pizza and Politics was moderated by a teen, who is a former Chair of the Cupertino Teen Commission. To date, there have been over 500 views of this forum and survey participants rated the event four out of five stars.
