4/8	C7	Identity Theft	Between 2/1 and 3/19, unknown suspect(s) used the victim's personal information to open a PayPal account and made over \$250 in unauthorized purchases. The victim reported the fraudulent PayPal activity prior to sustaining any financial loss. The victim lives in Cupertino.

An investigation revealed the suspect driver had two unregistered firearms concealed in the vehicle. The suspect was also in possession of multiple collapsible batons, canisters of pepper spray, and Methamphetamine. The suspect was arrested and booked into Main Jail.
